Does not need to connect. **Near Falls:** All 2 count pin attempts are totaled. **1.** Count of unique weapon types used during match. Example: Chair is used, counts as 1. No additional chairs count **2.** Black Mass, Styles Clash, Calf Crusher or Phenomenal Forearm **3.** Defined as area within barriers around ring. Ends at base of ramp on open end. Timekeeper area is not part of ring area. **4.** Member of 3 person team that makes or takes the fall.
